These services advance PHRC's statutory mission through public education, civic participation, community outreach, and civil rights awareness consistent with Commonwealth compliance requirements.**

Its direct involvement in civil rights advocacy, voter engagement, education equity, and community-based programming aligns precisely with PHRC's mission, vision, and enforcement framework. The proposed services are grounded in the NAACP's original scholarship, lived experience, institutional knowledge, and community relationships, making substitution by another provider impractical and ineffective.
