# ORIGINAL BONDS AND LICENSE RENEWAL ENFORCEMENT; VIOLATIONS FOR OPERATING WITHOUT A LICENSE

The Board will continue strictly enforcing Milk Marketing Law license renewal requirements for the 2023-2024 license year. See attached Bulletin 1608 for reference. The milk dealer, milk subdealer, and milk hauler license years begin July 1, 2023. Complete renewal applications for each of those licenses are due by June 15, 2023.

It is a violation of the Milk Marketing Law to operate without a license. It is also a violation of the Milk Marketing Law to do business with entities that are required to be licensed and are not licensed.

If a bond is required with the license application, the application is not complete until the Board receives the properly executed original bond. The online application system notes that the original bond must be mailed to the Board. However, if you attach an electronic copy of your bond to the online application, Board Staff will begin processing the application and your license will be issued more quickly when we receive the original bond.

On June 16, 2023, Board Staff will begin contacting licensees that have not submitted a complete renewal application, including the properly executed original bond if required. If a complete renewal application is not received and processed by June 30, 2023, the license will not be issued to be effective July 1, 2023.

On July 1, 2023, Board Staff will notify those that have not submitted complete renewal applications that they are operating without a license. Board Staff will also begin notifying customers and vendors of those operating without a license that they will be in violation of the Law if they do any business with unlicensed entities.
