**MENNO BEILER AND RELATED ENTITIES SIMPLY REAL MILK, LLC, NORTH  
UMBERLAND DAIRIES, NORTHUMBERLAND DAIRIES, MILK MARKETING  
SERVICES, AND MONTOUR DAIRIES, LLC**

Menno Beiler is operating several unlicensed milk dealers.

On June 1, 2026, the Chester County Court of Common Pleas entered the attached Preliminary Injunction Order. The Order enjoins Menno Beiler and related entities from engaging in any and all milk dealing operations.

The Board suggests that licensees engaged in Board-regulated activity involving Menno Beiler and related entities develop an exit strategy and wind down the relationship as quickly as practicable.

**ORDER**

AND NOW, this 1st day of June, 2026, upon consideration of Plaintiff Pennsylvania Milk Board's Motion for Preliminary Injunction filed March 16, 2026, to which no response was filed, and after a hearing held this day at which Defendants failed to appear despite proper notice having been given, it is hereby **ORDERED** that Plaintiff's Motion is **GRANTED** for the reasons set forth by the Court on the record. It is hereby **FURTHER ORDERED** that:

- A. Defendants Menno Beiler, Simply Real Milk LLC, North UMBERland Dairies, Milk Marketing Services, and Montour Dairies, LLC, are hereby enjoined from engaging

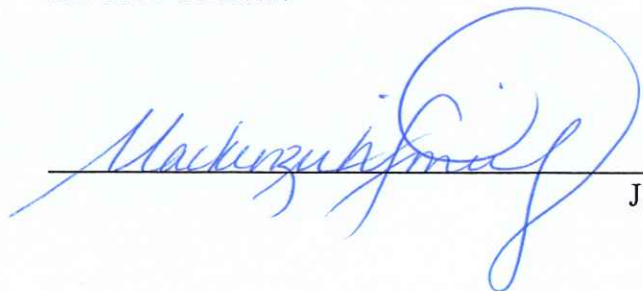
in any and all milk dealing operations, including but not limited to purchasing milk from producers;

- B. Defendants shall allow Plaintiff Pennsylvania Milk Board and any member or employee thereof to inspect any of Defendants' real or personal property and any audits, invoices, proof of payments, or other financial data for purposes of granting a milk dealer license to any of the Defendants; and
- C. Nothing in this Order shall be construed to prohibit Defendants, or any of them, from making payment to any producer that is due and owing as of the date of this Order.

It is further **ORDERED** that an administrative conference is scheduled for Monday, August 17, 2026 at 10:30 a.m. in Courtroom 18 of the Chester County Justice Center. Any request to appear remotely must be submitted at least five days prior to the conference. The parties are directed to comply with Chester County Local Rule of Civil Procedure 249.1(c) related to the filing of administrative conference memoranda.
