LICENSE NON-RENEWAL NOTIFICATION AND ENFORCEMENT MILK DEALERS

Milk Dealer license renewals are due by June 15 each year. The license year begins July 1.

It is a violation of the Milk Marketing Law to operate as a Milk Dealer without a license. It is also a violation of the Milk Marketing Law for licensed Milk Dealers to do business with unlicensed Milk Dealers.

Below is a list of unlicensed Milk Dealers as of July 8, 2026. Effective July 15, 2026, Staff will begin making legal referrals for licensees who continue to do business with these unlicensed entities. Staff will also institute legal proceedings directly against unlicensed entities as necessary.
