

LEGAL CASE DISPOSITIONS

September 2, 2026

1. Pennsylvania Milk Board v. The Origin Milk Company, Inc.

License No. 10005711 (Dealer)

Docket Nos. CE-26-001 and CE-26-005

Violations: (1) Defendant failed to file its Milk Dealer's Monthly Report for September 2025, in violation of Section 702 of the Milk Marketing Law, ("Law"), Act of April 28, 1937, P.L. 417 *as amended* (31 P.S. § 700j-702), and Section 147.10 of the Regulations of the Pennsylvania Milk Board (7 Pa. Code § 147.10).

(2) Defendant failed to file its December 2025 license fee calculation sheet and respective monthly license fee, in violation of Section 700k-4 of the Milk Marketing Fee Act ("Act"), Act of July 1, 1978, (P.L. 730) *as amended* (31 P.S. § 700k-4).

Disposition: Defendant executed a Consent Order in lieu of a hearing acknowledging the violations set forth in both citations. The Defendant agreed to pay a penalty of \$300.00 in resolution of the matters, and Board staff have received a check in the agreed-upon amount.

2. Pennsylvania Milk Board v. Core-Mark US, LLC (West Mifflin)

License No. 10004012 (Subdealer)

Docket No. CE-26-016

Violation: Defendant failed to timely renew its Milk Subdealer license on or before July 1, 2026, in violation of Section 513 of the Law. 31 P.S. § 700j-513. Defendant's Milk Subdealer license and required documentation was received on July 9, 2026.

Disposition: Defendant executed a Consent Order in lieu of a hearing acknowledging the violation set forth in the citation. The Defendant agreed to pay a penalty of \$900.00 in resolution of the matter, and Board staff have received a check in the agreed-upon amount.

3. Pennsylvania Milk Board v. Saputo Cheese USA Inc. TX

License No. 10003390 (Dealer)

Docket No. CE-26-027

Violation: Defendant failed to timely renew its Milk Dealer license on or before July 1, 2026, in violation of Section 403 of the Law. 31 P.S. § 700j-403. Defendant's Milk Dealer license and required documentation was received on July 13, 2026.

Disposition: Defendant executed a Consent Order in lieu of a hearing acknowledging the violation set forth in the citation. The Defendant agreed to pay a penalty of \$600.00 in resolution of the matter, and Board staff have received a check in the agreed-upon amount.

4. Pennsylvania Milk Board v. Saputo Cheese USA Inc. MN

License No. 1081100 (Dealer)

Docket No. CE-26-028

Violation: Defendant failed to timely renew its Milk Dealer license on or before July 1, 2026, in violation of Section 403 of the Law. 31 P.S. § 700j-403. Defendant's Milk Dealer license and required documentation was received on July 13, 2026.

Disposition: Defendant executed a Consent Order in lieu of a hearing acknowledging the violation set forth in the citation. The Defendant agreed to pay a penalty of \$600.00 in resolution of the matter, and Board staff have received a check in the agreed-upon amount.

5. Pennsylvania Milk Board v. Saputo Cheese USA Inc. KY

License No. 1052900 (Dealer)

Docket No. CE-26-029

Violation: Defendant failed to timely renew its Milk Dealer license on or before July 1, 2026, in violation of Section 403 of the Law. 31 P.S. § 700j-403. Defendant's Milk Dealer license and required documentation was received on July 13, 2026.

Disposition: Defendant executed a Consent Order in lieu of a hearing acknowledging the violation set forth in the citation. The Defendant agreed to pay a penalty of \$600.00 in resolution of the matter, and Board staff have received a check in the agreed-upon amount.
