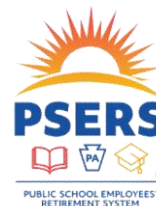


December 11, 2025 PSERB Defined Contributions Committee Meeting

5.1 **Q3 2025 Review**


Jennifer Mills presented the Q3 2025 Review.
