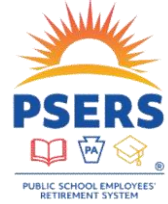


March 19, 2026 PSERB Benefits and Appeals Committee Meeting

5.3 **Deputy Executive Director Report**


Jennifer Mills presented the Deputy Executive Director Report which included a review of member services, member self-service transactions, and employer services updates.
