You can access your PSERS DC account through the PSERS Member Self-Service (MSS) Portal. To start, you'll need to register for a MSS account.



First time users Visit PSERS online

- 1 Click *Member Self-Service (MSS) Portal Access*.
 - Click *Register/Log in to MSS Portal*.
 - Click *Register*, read and accept the terms and conditions, then provide your PSERS ID, social security number, and date of birth.
- 2 Create a username and password to set up your MSS account, then choose and answer three security questions to complete your registration.
- 3 Log in to your MSS account. On your MSS home page, click the link in the *Voya Account Access* box to access your PSERS DC account.

Go to the app store on your phone or smart device and search keyword: Voya Retire. Download the app, open it, and click *Register* to create your PSERS DC account username and password. You can also set up the app to remember you or use the face/touch ID capabilities for convenient login in the future.
