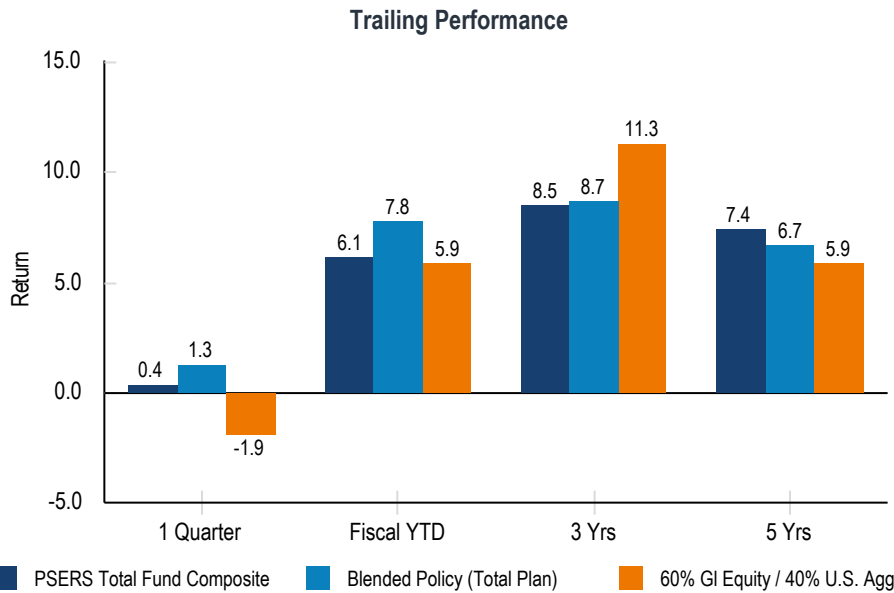

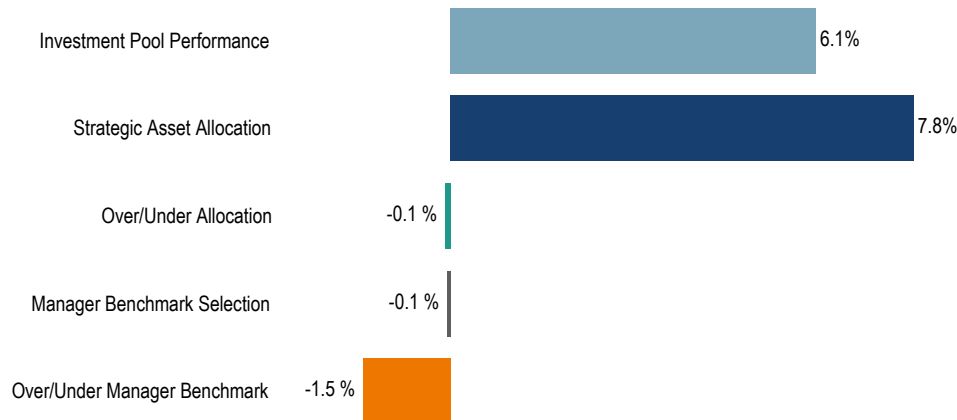

Fiscal Year to Date Performance Attribution



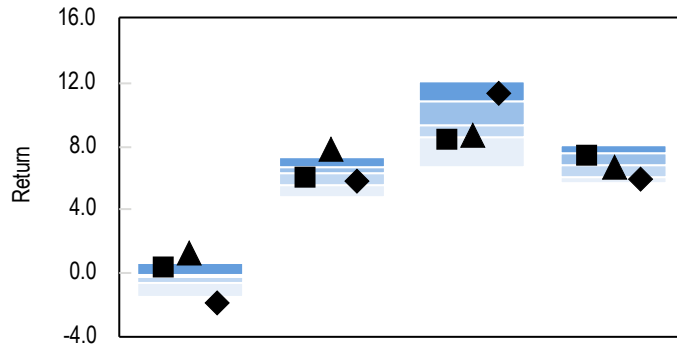
Fiscal Year to Date Performance Commentary Relative to Policy

PSERS total fund returned 6.12% fiscal year to date and underperformed its blended policy benchmark return of 7.78% by 165 basis points.

Asset allocation differences from policy contributed -0.11% to the total fund return for the fiscal year to date period. Slightly higher allocations relative to policy within Gold were most beneficial (+0.32%). A small underweight to public commodities (excluding Gold) detracted -57 bps from the total fund return FYTD.

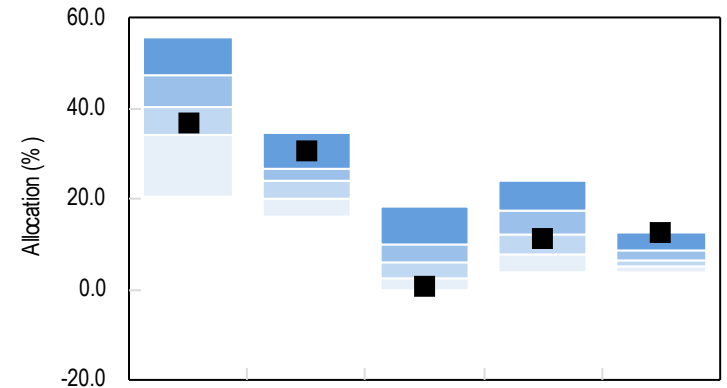
Manager performance detracted -1.48% from the total fund return fiscal year to date, primarily due to performance within private equity (-0.96%) and non-U.S. equity (-0.62%). Manager performance within private infrastructure was most beneficial, contributing 0.22% for the FYTD period.

Performance vs. InvMetrics Public DB > \$5Bn



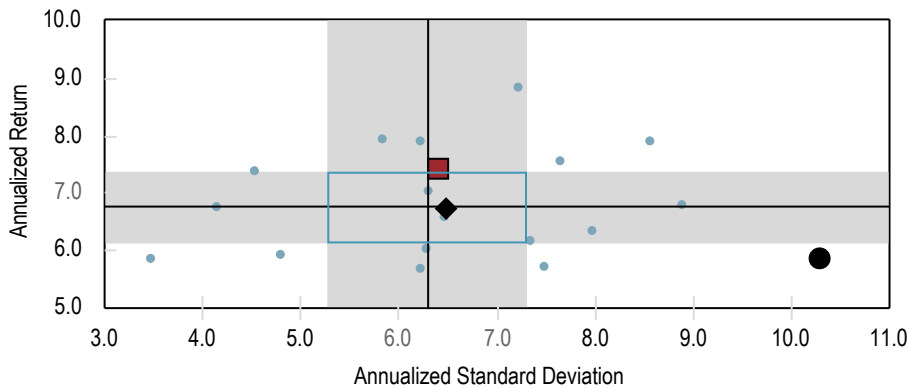

Fiscal Year to Date Performance Commentary Relative to Peers

PSERS ranked behind the median peer (62nd percentile) for the fiscal year to date period. The median peer returned 6.4% compared to PSERS return of 6.1%. The global 60/40 portfolio returned 5.9%.

Fixed income positioning was a headwind relative to peers FYTD. PSERS allocates 30.7% of the portfolio to fixed income compared to the median peer allocation of 24.3%. Broadly speaking, fixed income underperformed relative to public equities and real assets.

Private real estate positioning was also a headwind relative to peers. PSERS allocates 12.7% of assets to real estate and private infrastructure, which ranks in the top 4% among peers. Within that allocation, 6.6% is dedicated to private real estate, which posted negative returns FYTD and underperformed relative to other asset classes.

In the plan peer allocations, total equity includes public infrastructure, but does not include private equity. Total fixed includes private credit. Total real estate includes private infrastructure.

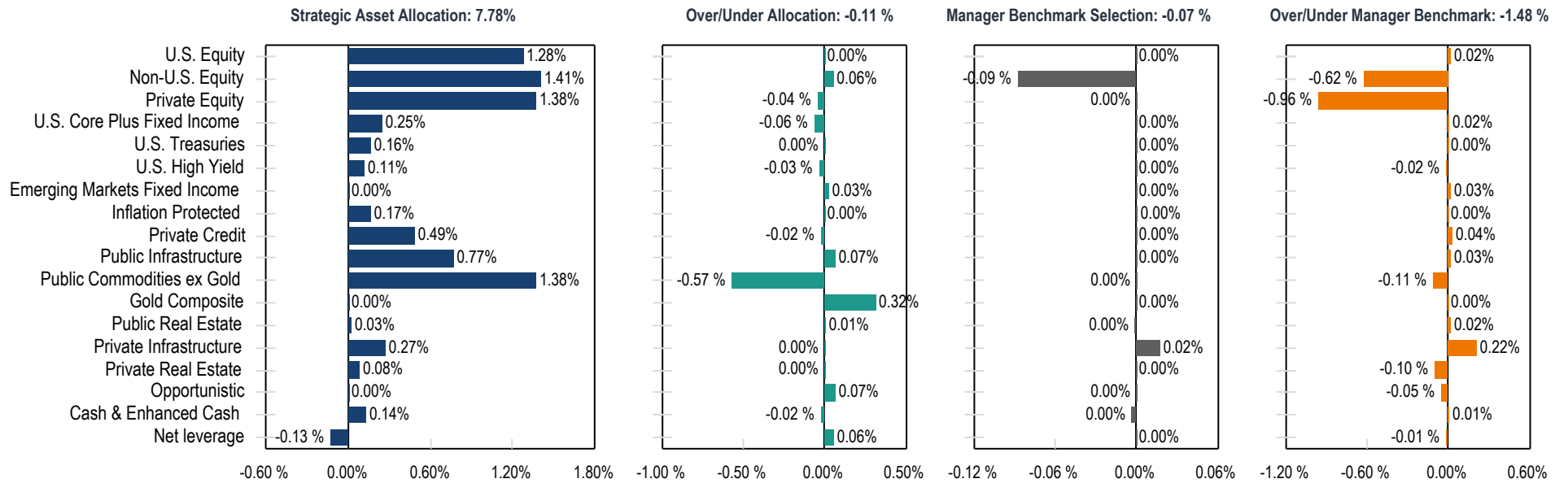

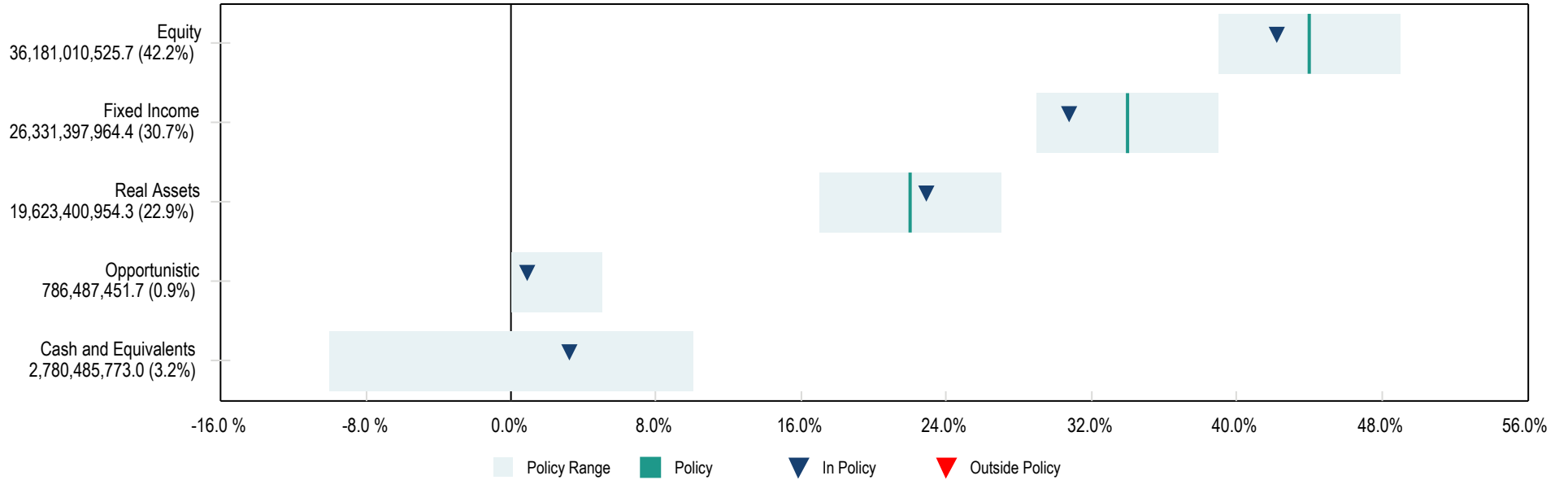

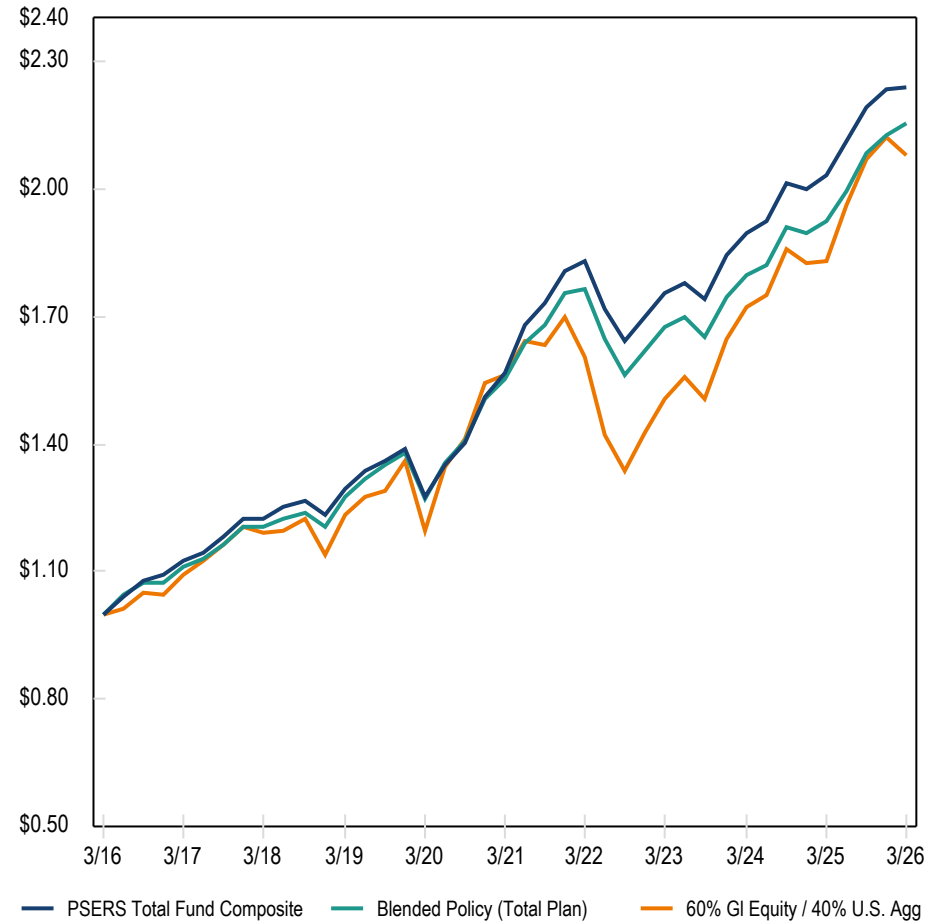

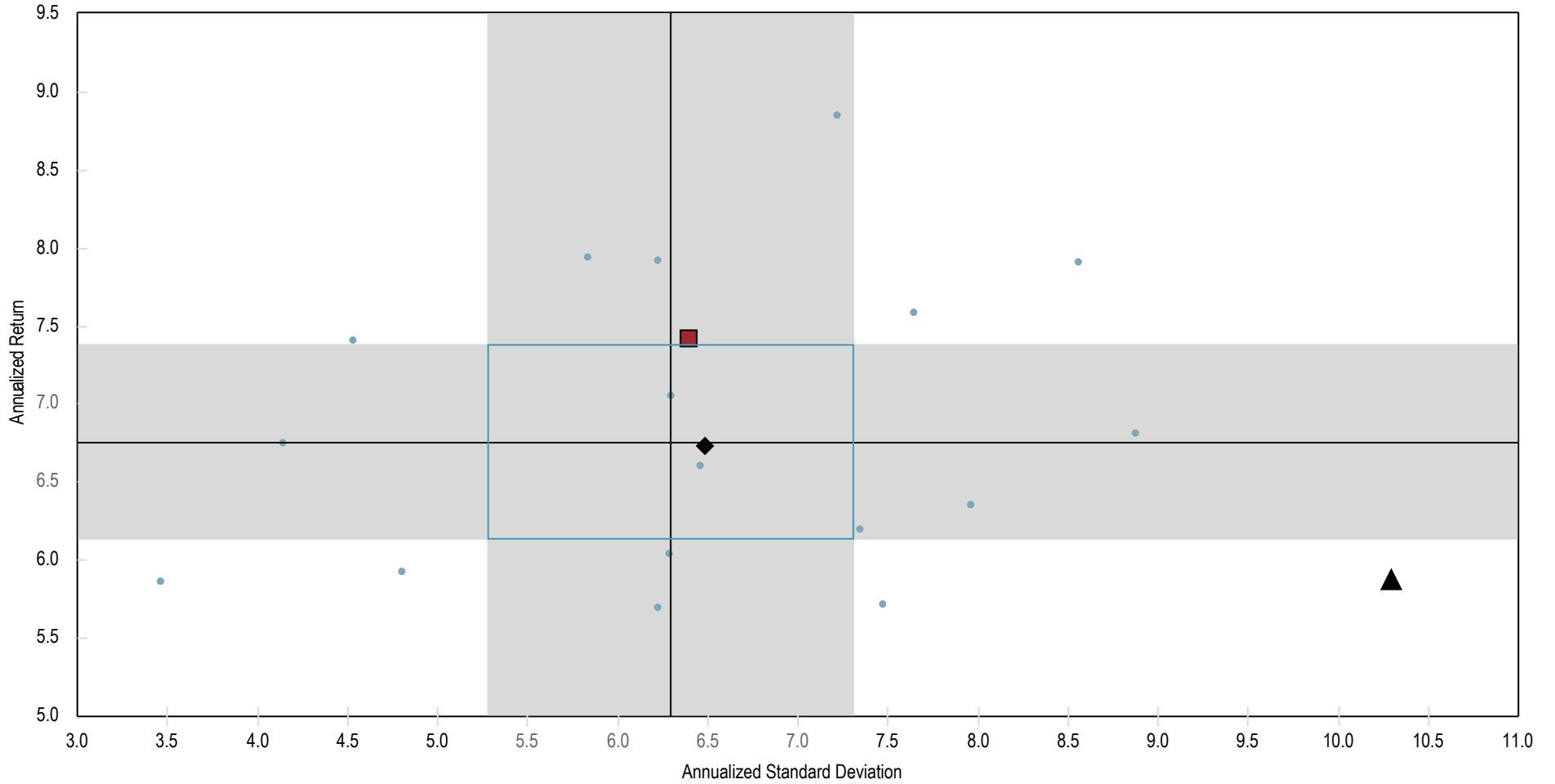
