1. Describe the unique features of this procurement that prohibit a competitive environment. If applicable, attach a Statement of Work.		
Hunton Andrews & Kurth has represented PSERS in cyber liability issues and served as our retainer cyber breach coach and ransomware negotiator since 2022. As one of only a few firms specializing in this field and providing cyber event coach and negotiation services to organizations of our monetary size, they are uniquely qualified to ensure PSERS is prepared in the event of a cybersecurity event, especially a ransomware attack. They have closely worked with PSERS's cyberinsurance brokers and insurance providers to review policy coverage and terms and are approved for these services under cyber liability and crimes insurance policies. The firm also presents on public fund cyber security best practices to the PSER Board and continues to work with PSERS legal and Information Security Office staff to develop and review a comprehensive cybersecurity plan to protect PSERS Members.		
2. Document and attach the research that has been conducted to date to verify the supplier is the only known source?		
Since Hunton Andrews & Kurth has represented PSERS for the past five years and one of few firms in this legal sector, it is impractical to change firms due to their knowledge of and expertise with PSERS.		
3. How has the material or service been procured in the past? Provide previous source justifications, contracts and POs.		
Previously services were procured through a legal services agreement and paid via funds commitment 4000025438.		
4. If this is an upgrade, addition, alteration, etc., to an earlier procurement, please describe in detail.		
This Sole Source will extend the services and current agreement/contract currently being provided through funds commitment 4000025438.		
5. What are the consequences of not approving this procurement?		
Due to the timing of PSERS's cyberinsurance policy reviews and renewal, not approving this procurement would cause a lapse in services, and thus, jeopardize PSERS's ability to negotiate and review cyberinsurance policies and inhibit ISO staff's ability to develop a comprehensive cybersecurity plan. Additionally, a lapse in service leaves PSERS unprepared in the event of a ransomware attack, as the firm serves as our Incident Response Plan breach coach and ransomware negotiator.		
6. If timing is a factor, what is the time factor and why?		
Yes. The current agreement will end on 12/29/2026 and these services are needed to ensure proper preparation and handling if a cyber security incident or data breach occurs. There is insufficient time to develop a solicitation, award and contract with a vendor causing an unacceptable lapse in services.

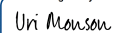
