Vehicle Weighing & Measuring Training Course

This training course is utilized by the Commonwealth of Pennsylvania to certify enforcement officers in the use of weighing equipment as required by the Vehicle Code (Title 75 Pa.C.S. § 4981(a)).

Course Objectives:

- Provide enforcement officers with the basic information needed to weigh and measure vehicles.
- Familiarize officers with the Vehicle Code (Title 75 Pa.C.S., Chapter 49) Size, Weight and Load.
- Familiarize officers with the Oversize/Overweight Permit Regulations (Title 67 Pa. Code, Chapter 179).
- Provide officers with guidance on how to properly weigh and measure vehicles.
- Provide officers with information on prior court cases involving size and weight enforcement.
- Provide officers with enforcement guidelines applicable throughout the Commonwealth of Pennsylvania.

Program Requirements:

- Full attendance for the entire three days of class, 8 am to 4 pm, with a one-hour break for lunch.
- Successful completion of the training course, to include passage of a written test, by a score of 80%.

2024 MP Vehicle Weighing and Measuring Training Schedule:

Class will be held at the Public Safety Training Center, 1760 S Easton Rd, Doylestown, PA 18901

Class will be held at the Public Safety Training Center, 1000 Maintenance Building Dr, Cranberry Township, PA 16066-1606

Applicant Selection Criteria:

- Class size will be limited to 25 officers.
- Agency (Chief) must enter into written agreement with PSP regarding participation requirements.
- Agency must participate in annual FHWA weighing data reporting to PSP with regards to each Agency's vehicle weighing activities. Explained in class.
- Participants should bring the following with them to each class: writing utensils, highlighters, note paper, calculator, and a blank USB thumb drive.
- A copy of all applicable Laws and Regulations, and other printed training materials, will be provided.

NOTE: Applications will be accepted up to July 14, 2024, **except for Bucks County, which will be until August 5, 2024.** Applicants will receive a confirmation email from CVSD their application was received by our office the following business day. Applicants are advised not to contact CVSD to ascertain the status of their application unless they have not received a confirmation. Applicant selection will be in the order of when completed applications are received with priority given to getting as many agencies involved as possible. The number of applicants selected from a single Agency may be limited to accomplish this goal.
