### **State Police Investigate Walmart Interaction**

**Belle Vernon, PA** – The Pennsylvania State Police Troop B is currently investigating an incident involving a viral video that was recorded at a Walmart in Rostraver Township and posted on Facebook.

The original incident was handled by the Rostraver Township Police Department and has since been referred to our Criminal Investigation Unit. The investigation remains very active, with multiple interviews being conducted and multiple pieces of information and evidence being gathered.

We will continue to work on this investigation jointly with the Rostraver Township Police Department, the Federal Bureau of Investigation, and personnel from local District Attorney's Offices.

**Crash Synopsis:**

This reportable crash occurred in the following manner; Unit #1 was traveling south on Grindstone Rd. Operator #1 was negotiating a right curve in the road when Unit #1 lost traction and continued straight. Operator #1 attempted to avoid collision by applying his brakes. However, this yielded negative results. Unit #1 exited the roadway via the northbound shoulder and struck a utility pole. Operator #1 then reversed Unit #1 off of the utility pole and rolled down Grindstone Rd. southbound coming to a slow and controlled final rest in a parking lot with the hood of the vehicle facing east. Operator #1 left the scene, as the weather was hazardous with below freezing temperatures. Unit #1 remained parked at the apartment building.

This reportable commercial vehicle crash occurred in the following manner. Unit #1, a white 2026 Freightliner was traveling west bound down the I-70 on ramp from SR-51. Unit #1 came to a complete stop at the stop sign at the end of the ramp. Unit #2, a white 2017 Honda HR-V was driving west bound on I-70 in the right lane. Operator #1 failed to yield to oncoming traffic and began to enter I-70. Operator #1 pulled out in front of Unit #2 in the right lane of I-70 West. This action resulted in Unit #2 striking Unit #1 in its 8 o'clock position. Unit #1 sustained disabling damage to its driver side rear fender and wheel area. Unit #2 sustained damage to its passenger side front fender, hood, and wheel area. Both Operators were not injured in the crash. Unit #1 was towed from the scene by Gary's Truck Repair. Unit #2 and it's trailing Unit were towed from the scene by Gary's Truck Repair by request of Operator #2 and his Safety Officer. The right lane of I-70 was closed for approximately one hour. Traffic control was directed by the Fire Dept. I was assisted on scene by Rostraver V.F.D and Tpr. HILL.

Crash Synopsis:

This crash occurred in the following manner, Unit 1 was traveling northbound on Bells Mills Road, South Huntington Township, Westmoreland County. As operator 1 was driving on Bells Mills Road, he attempted to navigate a slight downhill left turn. As operator 1 was attempting to make the left turn he lost traction due to snow and icy conditions of the roadway. Operator 1 then exited the roadway via the northbound shoulder. Shortly after exiting the roadway, operator 1 struck a concrete culver. The result of the impact caused minor damage. Unit 2 was also driving on Bells Mills Road heading northbound attempting to negotiate a slight left downhill turn. However operator 2 was driving too fast for the snow and icy conditions resulting in operator 2 also exiting the roadway via the right shoulder. After exiting the roadway operator 2 struck a tree at the 12 o clock position. The resulting impact caused disabling damage to unit 2. Operator 2 left the area prior to my arrival on scene. Operator number 3 was also driving on Bells Mills road attempting to negotiate a slight left downhill turn. Operator 3 was also driving too fast for the snow and icy conditions causing the loss of traction. Operator 3 struck the rear of unit 1. The impact caused minor damage to unit 3. Unit 1 and 3 were drivable. Unit 2 was towed from the scene by Palko Towing. Operator 1 and 3 were uninjured in the crash.
