INCIDENT DETAILS:

In March 2025, the Pennsylvania State Police at Hollywood Casino - Penn National were contacted by Hollywood Casino - Penn National Management after they learned about recently reported suspicious activity. It was reported an employee from the Hollywood Casino - Penn National Horse Racing Office was assisting with completing paperwork and filing when they observed numerous discrepancies to possibly include fictitious accounts, unidentified person(s) and/or businesses, improperly completed paperwork and numerous suspicious transactions completed on software they utilize, resulting in suspicious movement and issuing of a significant amount of money. Hollywood Casino - Penn National Management determined these discrepancies were not accidental or clerical errors, resulting in their reporting this incident. Through investigation, it was learned a former female employee conspired with a family member and fraudulently transferred hundreds of thousands of dollars and created false accounts, utilized false identities and businesses to receive that transferred money themselves via checks issued by that former employee. Charges will be filed in Magisterial District Court 12-3-05.
