**Crash Synopsis:**

**This crash occurred when Unit 1 was traveling west on Route 356 in Summit Township, Butler County, PA. The vehicle left the right side of the road and then came back on to Route 356. The vehicle began to spin, went off the left side of the road, overturned, and struck a tree. Operator 1 and the front right seat passenger sustained fatal injuries from the crash. The rear seat passenger was ejected from the vehicle and sustained suspected serious injuries. The passenger was transported to UPMC Presbyterian by Stat Medevac.**
