INCIDENT DETAILS:

On 09/10/26 at approximately 1059 hours PSP Ebensburg responded to the Conemaugh Miners Medical Center (CMMC) for an assault that occurred at a residence with a physical location of 1208 Theatre Road, Susquehanna Township, Cambria County, PA. The female juvenile victim a n 8 week of age B/N-F was admitted for treatment by her mother who reported this incident. This incident occurred as the victim was being fed by the mother at approximately 0400 hours this day. The mother related that upon touching the victim's armpit area, the victim would cry and acted abnormally. It was discovered the victim slept with the father/actor the prior night. Physicians from Conemaugh Miner's attempted to ascertain additional information from the mother who was evasive and hesitant to answer questions. Further contact was attempted with the actor who refused to speak to the physician and made comments of fleeing. A physical exam was performed on the victim and it was determined a clavicle fracture was present with abnormalities within the head. As a result of the physical exam a suspicion for nonaccidental trauma was present and a transfer to Children's Hospital of Pittsburgh was recommended and initiated. Through investigation it was determined the actor dropped the victim in the early morning hours. The actor had an active arrest warrant and was taken into custody and transported to PSP Ebensburg. The Cambria County District Attorney's Office was consulted and approved criminal charges of Aggravated

Assault and Endangering the Welfare of Children, filed through MDJ 47-3-05. The actor was then lodged in the Cambria County Prison to await arraignment.
