This crash occurred as Unit #1 struck the rear end of Unit #2 while traveling East on Interstate 76. Both Units pulled to the Southern berm after impact in order to exchange information but Unit #2 then left the scene. Operator #1 and Passenger #1 were wearing their seat belts and reported no injuries. Unit #1 could be driven from the scene under its own power.

The only information for Unit #2 is that it is a white in color mid-size SUV
