Crash Synopsis:

This crash occurred as Unit #1 was traveling Southbound on State route 305 (Shavers Creek Road) approximately 20 yards south of Bethel Road, West Twp., Huntingdon Co. As Unit #1 was traveling southbound Operator #1 failed to maintain his lane of travel and traveled off of the southbound shoulder and side swiped a guard rail withs its passenger side. Operator #1 then swerved into the northbound lane as it was crossing a bridge and side swiped the bridge barrier with its driver's side. When Unit #1 struck the bridge barrier the Rhino side by side ATV that was being hauled in a trailer of Unit #1 dislodged from the tow winch that was holding it down and launched over the bridge barrier and landed in a grassy area on the southbound side of the river off of the northbound lane. Operator #1 sustained minor injuries but signed off on medical treatment. Operator #1 was also placed under arrest for DUI. Unit #1, the trailer and sis by side were towed from the scene by Derek's Towing. I was assisted on scene by Shaver's Creek Fire Company.
