**Crash Synopsis:**

On 06/30/2026 at approximately 1147 hours, PSP was dispatched to a two vehicle crash in the area of Rose Street, White Township, Indiana County. This crash occurred as Unit 1 was stopped on Rose Street, attempting to make a left turn into Dunkin Donuts traffic way. As Unit 1 was turning left, Unit 2 was traveling north on Rose Street. Unit 2 was unable to avoid collision and subsequently struck Unit 1. Unit 2's 12 o'clock position struck Unit 1's 12 o'clock position. Unit 1 sustained disabling damage to its 12 o'clock position. Unit 2 sustained moderate damage to its 12 o'clock position. Upon arrival, I observed Unit 1 parked in a parking stall in the Dunkin Donut traffic way with disabling damage to its 12 o'clock position. I observed the Operator and Passenger of Unit 1 in the back of Citizens Ambulance being evaluated by EMS. I observed Unit 2 parked on the western portion of the roadway parking in a parking stall. I observed Unit 2 with moderate damage to its 12 o'clock position. I observed the Operator and Passenger of Unit 2 standing along side Unit 2. All Operators and Passengers were evaluated by EMS in which no injuries were sustained. No damage was observed by any surrounding properties. Unit 1 was towed from scene by Import Auto. Unit 2 was driven from scene. Assisted on scene by Citizens EMS.
