Update: Officer-Involved Shooting

Indiana Borough, PA – The Pennsylvania State Police Troop A Major Case Team wishes to provide details regarding an officer-involved shooting that occurred yesterday evening in Indiana Borough, Indiana County.

On June 28, 2026 at approximately 7:02 p.m., Officers with the Indiana Borough Police Department were dispatched to a domestic disturbance at a residence within the 100 block of North Cherry Avenue in Indiana Borough.

While the Officers were on-scene, the involved male brandished a shovel and threatened an Indiana Borough Police Officer with the shovel. A foot pursuit ensued and the Officer was able to catch up with the suspect.

As the Officer attempted to detain the suspect, the suspect stabbed the Officer with a knife multiple times in the head and face area. During this struggle, the Officer discharged their duty pistol, striking and fatally wounding the suspect.

The injured Officer was transported to Indiana Regional Medical Center for treatment of their injuries.

The suspect was pronounced deceased at the scene. Notifications to next-of-kin are pending.

Assisting agencies included the Indiana County District Attorney's Office, the Indiana County Coroner's Office, Indiana County Emergency Management Agency/911, the Indiana University of Pennsylvania Police Department, the Blairsville Borough Police Department, the Homer City Police Department, and Citizens' Ambulance Service.

Investigators with the Troop A Major Case Team were also assisted by the Troop A Forensic Services and Collision Analysis and Reconstruction Specialist Units and the Troop A, Indiana Patrol and Criminal Investigation Units.
