The following licensed establishments were cited by the PA State Police, Bureau of Liquor Control Enforcement, Allentown District Enforcement Office, during the month of July 2025:

BERKS COUNTY:

Ridgewood Winery LLC, Bechtelsville:

- On May 3, 2025, you, by your servants, agents or employees, produced or sold wine in contravention of the Liquor Code and Title 40 of the Pennsylvania Code in that the subject premises purchased wine in bottles from another Pennsylvania limited winery, but did not put these wine bottles through a second fermentation process, in violation of Section 505.2 of the Liquor Code, and Section 5.405 of the Liquor Control Board Regulations.
- You, by your servants, agents or employees, failed to maintain complete and truthful records covering the operation of the licensed business for a period of two (2) years immediately preceding June 20, 2025, in violation of Sections 471.1(f) and 493(12) of the Liquor Code.

Navarrete Services LLC, T/A Xoloitzcuintle Restaurant, Reading:

- On April 1 through 6, 8 through 13, 15 through 20, 22 through 27, 29 through May 4; May 9 and 10, 2025, you, by your servants, agents or employees, sold alcoholic beverages without authority in that your license expired and/or was held in safekeeping or your temporary operating authority expired, in violation of Sections 474.1(d), 491(1), 492(2) and 493(16) of the Liquor Code.
- On April 12, 26 and May 10, 2025, you, by your servants, agents or employees, permitted entertainment without an amusement permit, in violation of Section 493(10) of the Liquor Code.

Metacomet Home Assn. Of Reading, Reading:

• On May 2, 2025, you, by your servants, agents or employees, sold alcoholic beverages to nonmembers, in violation of Section 406(a)(1) of the Liquor Code.

BUCKS COUNTY

Casa Toro Inc, Fountainville:

• March 9, 2025 through May 21, you, by your servants, agents or employees, failed to have your Board-approved manager completed RAMP owner/manager training within 180 days of the Board's approval of the appointment, in violation of Section 471.1(g) of the Liquor Code.

Morrisville Beer Distributor Inc, Morrisville:

You, by your servants, agents or employees, failed to maintain complete and truthful records
covering the operation of the licensed business for a period of two (2) years immediately preceding
July 1, 2025, in violation of Sections 471.1(f) and 493(12) of the Liquor Code.

BUCKS COUNTY: cont'd

Murphy's Beef & Ale, Inc., Levittown:

- On April 19, 2025, you, by your servants, agents or employees, failed to require patrons to vacate
 that part of the premises habitually used for the service of alcoholic beverages not later than one-half
 hour after the required time for the cessation of the service of alcoholic beverages, in violation of
 Section 499(a) of the Liquor Code.
- On April 19, 2025, you, by your servants, agents or employees, permitted patrons to possess and/or remove alcoholic beverages from that part of the premises habitually used for the service of alcoholic beverages after 2:30 A.M., in violation of Section 499(a) of the Liquor Code.
- On April 19, 2025, you, by your servants, agents or employees, sold, furnished and/or gave alcoholic beverages between 2:00 A.M. and 7:00 A.M., in violation of Sections 406(a)(2) and 493(16) of the Liquor Code.

LEHIGH COUNTY:

West Side Republican Club of Bethlehem Inc., Bethlehem:

- During the period June 11, 2024 through June 11, 2025, you, by your servants, agents or employees, failed to adhere to constitution and/or by-laws, in violation of Section 5.81 of the Liquor Control Board Regulations.
- During the period June 11, 2024 through June 11, 2025, you, by your servants, agents or employees, failed to maintain records in conformity with the provisions of the Liquor Code and Title 40 of the Pennsylvania Code, in violation of Section 493(12) of the Liquor Code, and Sections 5.71 and 5.74 of the Liquor Control Board Regulations.

Gordon Grill Inc, Allentown:

 During the period December 5, 2024 through June 4, 2025, you, by your servants, agents or employees, failed to maintain complete and truthful malt or brewed beverage dispensing system cleaning records, in violation of Section 493(12) of the Liquor Code and Section 5.52 of the Liquor Control Board Regulations.

Cecebean LLC, T/A Rising River Brewing Company, Macungie:

 On February 19; March 14, 22; April 18, 19; May 4, 17 through 19, 24 and July 4 through 6, 2025, your licensed establishment was operated in a noisy and/or disorderly manner, in violation of Section 471 of the Liquor Code.

Chestnut Street Hospitality Group Inc, Emmaus:

• During the period May 30, 2024 through July 2, 2025, you, by your servants, agents or employees, failed to have an alcohol service person complete RAMP server/seller training within six (6) months of being hired, in violation of Section 471.1(h) of the Liquor Code.

Vighna Vinayak Inc, T/A Shell Quick Stop, Allentown:

 During the period April 1 through 21, 2025, the manager of your licensed premises was employed by or engaged in another business without Board approval, in that the manager devoted twenty-eight (28) hours a week at Nar Narayan Krupa, Inc., in violation of Section 5.23(a) of the Liquor Control Board Regulations.

MONTGOMERY COUNTY:

The Fort 325 LLC, T/A The Fort Kitchen and Bar, Fort Washington:

- During the periods November 28 through December 19, 2024, January 3 through 6, 21 through February 11; February 26 through March 13, March 28 through April 17 and May 2 through 4, 2025, you, by your servants, agents or employees, failed to clean malt or brewed beverage dispensing system at least once every fourteen (14) days, in violation of Section 5.51(c) of the Liquor Control Board Regulations.
- During the period May 1 through 28, 2025, you, by your servants, agents or employees, failed to have your Board-approved manager complete RAMP owner/manager training within 180 days of the Board's approval of the appointment, in violation of Section 471.1(g) of the Liquor Code.

Xo Bar LLC, Elkins Park:

 On March 20; April 15; May 3, 17 and June 9, 2025, your licensed premises was not a bona fide restaurant in that you, by your servants, agents or employees, maintained insufficient food items and seating, in violation of Section 102 of the Liquor Code.

The Jarrettown LLC, Dresher:

• During the period May 30, 2023 through June 15, 2025, you, by your servants, agents or employees, failed to notify the Board within fifteen (15) days of a change of manager, in violation of Section 5.23(c) of the Liquor Control Board Regulations.

Cobble Court Restaurant Investors LLC, T/A Cobble Court, Bryn Mawr:

- During the period June 16 through July 1, 2025, you, by your servants, agents or employees, failed to notify the Board within fifteen (15) days of a change of manager, in violation of Section 5.23 (c) of the Liquor Control Board Regulations.
- During the period May 15, 2023 through July 3, 2025, you, by your servants, agents or employees, failed to have an alcohol service person complete RAMP server/seller training within six (6) months of being hired, in violation of Section 471.1(h) of the Liquor Code.

NORTHAMPTON COUNTY:

Sette Luna, LLC, T/A Sette Luna, Easton:

- During the period April 27 through June 9, 2025, you, by your servants, agents or employees, failed to have your Board-approved manager complete RAMP owner/manager training within 180 days of the Board's approval of the appointment, in violation of Section 471.1 (g) of the Liquor Code.
- During the period August 4, 2023 through June 9, 2025, you, by your servants, agents or employees, failed to have an alcohol service person complete RAMP server/seller training within six (6) months of being hired, in violation of Section 471.1(h) of the Liquor Code.
- During the period September 16, 2023 through June 9, 2025, you, by your servants, agents or employees, failed to ensure an alcohol service person completed RAMP server/seller training within the past two (2) years, in violation of Section 471.1(h) of the Liquor Code and Section 5.204 of the Liquor Control Board Regulations.

Wilson Democratic Assn. Of Wilson Borough, Easton:

FIRST CAUSE OF ACTION: THE PENNSYLVANNIA LOCAL OPTION SMALL GAMES OF CHANCE ACT


 You, by your servants, agents or employees, failed to maintain complete and truthful records covering the operation of the licensed business for a period of two (2) years immediately preceding June 22, 2025, concerning the Local Option Small Games of Chance Act, in violation of Section 328.503 of the Local Option Small Games of Chance Act and Sections 901.461-468 of the Department of Revenue Regulations.

SECOND CAUSE OF ACTION: THE PENNSYLVANIA LIQUOR CODE

- During the period January 26, 2021 through June 22, 2025, you, by your servants, agents or employees, failed to adhere to constitution and/or by-laws, in violation of Section 5.81 of the Liquor Control Board Regulations.
- During the period January 26, 2021 through June 22, 2025, you, by your servants, agents or employees, failed to fulfill charter purposes, in violation of Section 102 of the Liquor Code.
- During the period December 22, 2024 and January 11, 2025, you, by your servants, agents or employees, failed to maintain records in conformity with the provisions of the Liquor Code and Title 40 of the Pennsylvania Code, in violation of Section 493(12) of the Liquor Code and Sections 5.71 and 5.74 of the Liquor Control Board Regulations.

Doyl Ramen Inc, T/A Takkii Ramen, Freemansburg:

- During the period August 20, 2024 through January 28, 2025, you, by your servants, agents or employees, failed to maintain complete and truthful malt or brewed beverage dispensing system cleaning records, in violation of Section 493(12) of the Liquor Code and Section 5.52 of the Liquor Control Board Regulations.
- You, by your servants, agents or employees, failed to maintain complete and truthful records covering the operation of the licensed business for a period of two (2) years immediately preceding April 23, 2025, in violation of Section 5.101 of the Liquor Control Board and Section 493(12) of the Liquor Code.
- On February 11 and March 17, 2025, you, by your servants, agents or employees, failed to return records to the licensed premises within twenty-four (24) hours of a request by the Enforcement Bureau, in violation of Section 493(12) of the Liquor Code.
- During the period August 8, 2024 through December 31, 2024, you, by your servants, agents or employees, as a brewery, sold alcoholic products produced by other Pennsylvania licensed manufacturers in excess of fifty (50) percent of the sales of your alcoholic products in the current calendar year, in violation of Section 446(a)(2) of the Liquor Code.
- During the period August 8, 2024 through June 4, 2025, your licensed premises was not a bona fide brewery in that you sold alcohol produced by other manufacturers while failing to manufacture any of your own products or sell any products that you made, in violation of Sections 102, 431(a), 446(a) and 492(1) of the Liquor Code.
