On 07/06/2026 at approximately 1915 hours, Troopers from PSP Punxsutawney were dispatched to the area of Young Road and Eddy Road, Young Township, Jefferson County after electrical crews in the area discovered a dead dog in a residence. Upon arrival, three more dead dogs were discovered in and around the property. The investigation is ongoing.

Crash Synopsis:

On July 2, 2026, at approximately 2152 hours, Troopers from PSP Punxsutawney responded to a single vehicle motorcycle crash on State Route 28 in Clover Township, Jefferson County, approximately 0.6 miles south of Summerville Borough.

The investigation determined that the motorcycle was traveling in the northbound lane of State Route 28 when, for reasons that remain under investigation, the operator lost control. The motorcycle struck a guardrail along the roadway, ejecting the operator. The motorcycle continued across the roadway before coming to rest on the southbound lane shoulder.

The operator sustained serious injuries and was transported from the scene by STAT MedEvac helicopter to Penn Highlands Dubois for treatment.
