This crash occurred on 07/10/26 at approximately 0917 hours as Unit 2 was traveling northbound on SR0310 attempting to go straight. Unit 1 was traveling on Adrian Rd attempting to make a left hand turn. Unit 1 failed to yield to Unit 2 from the stop sign on Adrian Rd and pulled out directly into the path of Unit 2. Unit 2 attempted to swerve left to miss Unit 1, but made impact with the driver side of Unit 1 in the middle of the roadway. This caused Unit 1 to be pushed back up the roadway on the southbound side of the roadway. This was Unit 1's final resting position. Unit 2 went off the roadway on the southbound side of the roadway and was stopped by the embankment. This was Unit 2's resting position. Operator 1 was ejected from the vehicle and upon arrival was found lying in the grass next to the southbound side of the roadway. Operator 1 succumbed to his injuries he sustained as a result of the crash. Operator 2 received minor injuries in the crash. Both operators were transported by Jefferson County EMS to DuPont Hospital. Both vehicles received disabling damage and were towed from the scene.
