On 07/16/25, Dakota GREELEY plead guilty to count 2 Murder and Count 6, First Degree Murder of Unborn Child. GREELEY was sentenced by the Honorable Judge John FORADORA to pay fines and costs of prosecution, pay restitution and undergo two (2) life sentences without parole in a state correctional facility.
