INCIDENT DETAILS:

On 01/14/26 at approximately 1142 hours, PSP Stroudsburg was dispatched to 2535 Milford Road (The Dollar General) for the report of an assault that had just occurred. Through investigation, it was determined the victim was walking into the Dollar General for cigarettes. The victim related she encountered the actor, Donovan MACK, in the back of the Dollar General, outside, and smoking a cigarette. The victim related she approached MACK to see what he was doing. The victim related the Defendant became irate and started yelling at her. MACK then physically made contact with her by grabbing her hood and throwing it over her head. MACK threw her to the ground, punched her in the back of the head, and choked her to the point she believed she lost consciousness and "blacked out." The victim related she could not breathe after. The victim related the Defendant then took her phone and smashed it. The victim had visible injury. MACK had fled the scene prior to Troopers arrival. An area canvass was conducted by Troopers at the scene and at his residence, but negative contact was made with him.

After contacting the Monroe County District Attorney's Office, MACK was charged with Felony Aggravated Assault and Strangulation, along with Simple Assault, Disorderly Conduct, Harassment related charges. A full extradition warrant was obtained for his arrest through MDJ 43-4-01.
