Crash Synopsis:

This crash occurred on Painter Lick Lane in Columbia Township, Bradford County. An ATV was traveling northbound on Painter Lick Lane when it collided with a deer that had jumped out in the roadway. Neither of the occupants were wearing safety equipment. The operator of the ATV sustained serious injuries and was transported to Guthrie Troy Community Hospital. The passenger sustained extensive injuries from the crash and was pronounced deceased at the scene. A recently deceased deer was located on scene consistent with
