Crash Synopsis:

This crash occurred as all Units were traveling South on SR 24 N Main St near the intersection of Dixie Dr. Traffic was backed up in front of Unit 3 which prompted them to come to a complete stop. Unit 2, who was traveling behind Unit 3, began slowing down almost to a complete stop. Unit 1 was following too closely behind Unit 2 and rear-ended them. Following the initial collision, Unit 2 uncontrollably rear-ended Unit 3. Unit 3 sustained minor rear-end damage while Units 1 and 2 sustained disabling heavy front and rear-end damage and were towed by Baker & Son's. Operator 2 reported minor injuries and was transported by First Capital EMS.

Crash Synopsis:

This single vehicle non-reportable crash occurred on I-83 North near mile marker 6.6, Shrewsbury Township, York County, PA. This is an Interstate Highway with two lanes in the northbound direction. As Unit 1 was traveling North in the right travel lane, Operator 1 began to fall asleep and subsequently drifted onto the right shoulder and struck a solid snowbank. Operator 1 came to a final rest on the right shoulder where they remained upon Troopers arrival.

Minor damage was observed on the right passenger side fender of Unit 1. No injuries were reported and Unit 1 was able to be driven from the scene.
