Due to severe storms on July 11, 2026, that resulted in damage in Philadelphia, Pennsylvania, the Pennsylvania Disaster Recovery Assistance Program (DRAP) may be available to eligible residents who live in a Philadelphia zip code identified on page 2 of this notice.

DRAP is a grant program to aid recovery efforts for homeowners and renters who meet lower income thresholds, are uninsured or underinsured, and when other local, state, federal, non-governmental, or private aid is not available. For those who qualify, grants can be used to repair their home, cover temporary housing, or replace essential personal property.

Eligibility

To be eligible for DRAP:

1. The homeowner or renter must have suffered losses caused directly by the disaster.
2. The homeowner or renter must either:
 - a. Currently receive income-based government assistance
 - Or
 - b. Apply for an SBA Disaster Loan for this flooding event and be denied because of inability to repay or inadequate credit.
3. Household income must be below 500% of the most recent most recent [Federal Poverty Guidelines](#) published by the United States Department of Health and Human Services.
4. The applicant's primary residence must be in a municipality included in this DRAP activation.

Applicants not currently receiving income-based government assistance must provide the SBA disaster loan denial notification as part of the DRAP grant application. DRAP Program guidelines and eligibility requirements are on the PA Emergency Management Agency website at: pa.gov/ready/drap.

Municipalities included in this DRAP activation:

- Are in a county that received an SBA Disaster Declaration due to this event.
- Issued a disaster declaration within two weeks of the event.
- Reported at least one home with damage from the disaster event.
