APPROVAL OF MINUTES

The minutes of the May 9, 2012 meeting of the Council of Basic Education were approved on an E. Sheehan/Farmer White motion.

COMMITTEE REPORTS

SCHOOL AND UNIVERSITY SAFETY COMMITTEE

Jonathan Peri reported that, after a year and a half of hard work, the Chapter 10 (Safe Schools) regulation is scheduled for publication as a final rule on July 21, 2012, in the Pennsylvania Bulletin.

Mr. Peri noted that since the May State Board meeting, the regulation was approved unanimously by the Independent Regulatory Review Commission (IRRC) on June 21, 2012. Before this vote, the regulation was withdrawn in mid-May to address comments from staff of the Pennsylvania Emergency Management Agency (PEMA). Mr. Peri expressed thank to Board counsel Greg Dunlap for his work with PEMA, which resulted in a swift resubmission of the regulation. In June, PEMA Director Glenn Cannon wrote to IRRC in support of Chapter 10. In addition, Senators Jeffrey Piccola and Andrew Dinniman sent a letter of support to IRRC.

Mr. Peri also reported that, just two days before IRRC's unanimous approval, a tolling memo was received from the Office of Attorney General (OAG). Board Counsel submitted a reply to the OAG on June 25, with no changes to the regulation, and within three days the OAG approved Chapter 10.

REPORT OF THE DEPUTY SECRETARY ELEMENTARY AND SECONDARY EDUCATION

Deputy Secretary Carolyn Dumaresq called upon John Weiss, Director of the Bureau of Assessment and Accountability, to present on proposed transitions to the state's assessment system. He noted that the proposed transitions discussed in his presentation were contingent upon approval by the U.S. Department of Education, approval of proposed changes to Chapter 4 by the State Board, and funding from the legislature to support all testing activities.

Mr. Weiss provided the following overview of proposed transitions to the assessment system:

Keystone Exams

Mr. Weiss also reported that, in February, PDE staff met with the U.S. Department of Education (USDOE) regarding the proposal to use the Keystone Exams in lieu of the 11th grade PSSA. A concern raised during the meeting was how to ensure that every student is tested. PDE has formulated six different options in response to the concern raised by the USDOE.

Teacher Effectiveness

Dr. Dumaresq provided an update on omnibus changes to the School Code recently enacted by the General Assembly in Act 82 (House Bill 1901). She noted that the Act directs the Department to develop a new rating tool for teachers that takes into account elements of professional practice and multiple measures of student achievement.
