Introduction

The Pennsylvania General Assembly passed legislation (Act 50) in 1993 to establish the Keystone Recreation, Park and Conservation Fund.

The Pennsylvania Department of Education (PDE), through the Office of Commonwealth Libraries, administers the public library portion of this program through a competitive grant process. The competitive grant is used to award matching construction grants to municipalities that sponsor state-aided public libraries.

Grants pay up to 50 percent of eligible costs in planning, acquisition, construction and rehabilitation of public libraries. A dollar-for-dollar match is required for grant funds received. By providing money to make critical repairs and improvements and to build new public library buildings, the General Assembly has ensured better facilities to provide vital library services.

This report is being issued to meet the reporting requirements for the Keystone Recreation, Park and Conservation Fund grant program as required by the Pennsylvania General Assembly and the Office of the Governor. Throughout the report, the Keystone Recreation, Park and Conservation Fund will also be referred to as the Keystone Fund.

Overview


The last Keystone Recreation, Park and Conservation Fund Report was published and submitted to the Governor's Office and the General Assembly in April 2009 and covered Keystone Fund grant activity from 2004 through 2007. During this time, the Keystone Fund provided \$11,331,373 in grants to assist 67 library projects, which had a combined cost of \$52,207,570. All projects reported in the April 2009 report have been completed.

This report covers Keystone Fund grants awarded between 2008 and 2010.

- Keystone funds in the amount of \$2,237,655 were awarded to eight projects in 2008. All projects have been completed with four final reports pending.
- Keystone funds in the amount of \$3,662,456 were awarded to 15 projects in 2009. Six projects have been completed to date and the remaining nine projects are in progress.
- Keystone funds in the amount of \$164,657 were awarded to 16 projects in 2010. Three projects have been completed to date and the remaining 13 projects are in progress.

Keystone Fund 2008 Projects

In 2008, the Office of Commonwealth Libraries received 16 applications, requesting a total of \$4,182,394 in Keystone Fund grants, from municipalities on behalf of their public libraries. All applications were reviewed and approval for funding was given to eight library projects for a total of \$2,237,655. Keystone Fund grants may not exceed 50 percent of the total project cost, therefore each project was required to provide a dollar-for-dollar match of the grant awarded. The following chart illustrates the types of projects that were approved.



Keystone Fund 2009 Projects

In 2009, the Office of Commonwealth Libraries received 15 applications, requesting a total of \$3,662,456 in Keystone Fund grants, from municipalities on behalf of their public libraries. All applications were reviewed and approval for funding was given to all 15 library projects for a total of \$3,662,456. Keystone Fund grants may not exceed 50 percent of the total project cost, therefore each project was required to provide a dollar-for-dollar match of the grant awarded. The following chart illustrates the types of projects that were approved.


